# **Prospectus for the Mackie Lake House Foundation Artist-in-Residence Program 2022**



The Mackie Lake House Foundation Artist-in-Residence Program is a collaborative partnership between Mackie Lake House Foundation and Vernon Public Art Gallery (VPAG). The Artist-in-Residence Program is made possible through the generosity of Patrick (Paddy) Fylton Mackie who established and funded the Mackie Lake House Foundation. Patrick Mackie was a patron of the arts and a gifted artist in his own right and the Artist-in-Residence Program was established in his memory.

We are pleased to announce the call to artists for the 2022 Mackie Lake House Artist-in-Residence program. The residency is designed to offer established Canadian artists solitude and time to create. The residency includes a four-week stay at the Historic 1910 Mackie Lake House in Coldstream, BC, an honorarium, and a solo exhibition at the Vernon Public Art Gallery. The exhibition will include working sketches and finished works produced during the residency.

The purpose of the Artist-in-Residence program is to foster the discourse and production of visual arts by providing artists a place to pursue their artistic discipline in a tranquil location away from their normal busy life. One work of art inspired by the location and produced during the Residency will be donated to the Foundation to be displayed in the House. The artist will grant rights for the image to be reproduced as cards or small prints with full credit given to the artist

#### **Dates**

2022 Residency dates at Mackie Lake House: September 12 – October 9, 2022. Exhibition dates at Vernon Public Art Gallery: October 13th – December 21, 2022.

**Application deadline** Aug 14, 2022. Selection will be made by August 22, 2022.

### **Obligations**

While the intent of the Artist-in-Residence program is to offer the artist an opportunity to work on their artistic projects, it is expected that the artist will be available to talk to local media, participate in the Artist reception, September 17, 2022 at the Mackie Lake House, the Vernon Public Art Gallery Show opening on Thursday, October 13, 2022 and provide an Artist Talk at the Vernon Public Art Gallery on October 13, 2022. The artist's work will need to be delivered to the Vernon Public Art Gallery by noon, Tuesday, October 11, 2022.

Artists are responsible for their own transportation, food, communications and supplies while staying at Mackie Lake House, and they are also responsible for pick-up of work, or arrange the shipping of works after the completion of the exhibition at the VPAG. The honorarium of \$1000 will be distributed with \$500 at the beginning of the residency and the balance upon the completion of the residency.

## Location

Mackie Lake House is located on the shores of Kalamalka Lake in Coldstream, BC, a rural community near Vernon in the North Okanagan Valley. The house was built circa 1910 and is one of the finest surviving examples of Arts & Crafts style architecture in the Interior of BC. In 1987 the House was recognized as a Provincial Heritage Site and is listed as one of Canada's Historic Places. The House is now used for a wide variety of cultural and community events. Residency Information & Regulations

Please read and sign below, then return completed form to Mackie Lake House.

- 1. The Residency Guest are encouraged to have their partner or a friend join them while staying at Mackie Lake House (MLH). Other overnight guests may be permitted if pre-approved by the MLH Manager, advance notice is required.
- 2. The main floor, second floor, screened porch and laundry area in basement are accessible to the AiR. The MLH office and attic are restricted areas. Please note the second floor is only accessible by the use of the stairs.
- 3. Full kitchen facilities are available, but the Resident Guest is responsible for their own groceries and meal preparation.
- 4. MLH is environmentally conscious and expects recyclables to be separated, and composting bins are available.
- 5. The MLH premises must be kept neat, clean, and in orderly condition. The Resident Guest will be responsible for any breakage or damage to furniture or property during their stay.
- 6. Smoking is not permitted in the House. Candles or any flame are not permitted in the House or on the Grounds.
- 7. With the exception of trained assistance dogs, pets are not permitted in the House or on the grounds.
- 8. Wireless internet service is provided for your convenience while working and staying in the House.
- 9. The House and gates must be locked at all times when the Manager or the Resident Guest are off-site.
